If the construction or installation of any home improvement item(s) is (are) deemed non-compliant to the CC&Rs or Architectural Guidelines after being constructed or installed, even with an approved Home Improve Application. The Owner will be required to correct the non-compliance or de-construct the non-compliant item.

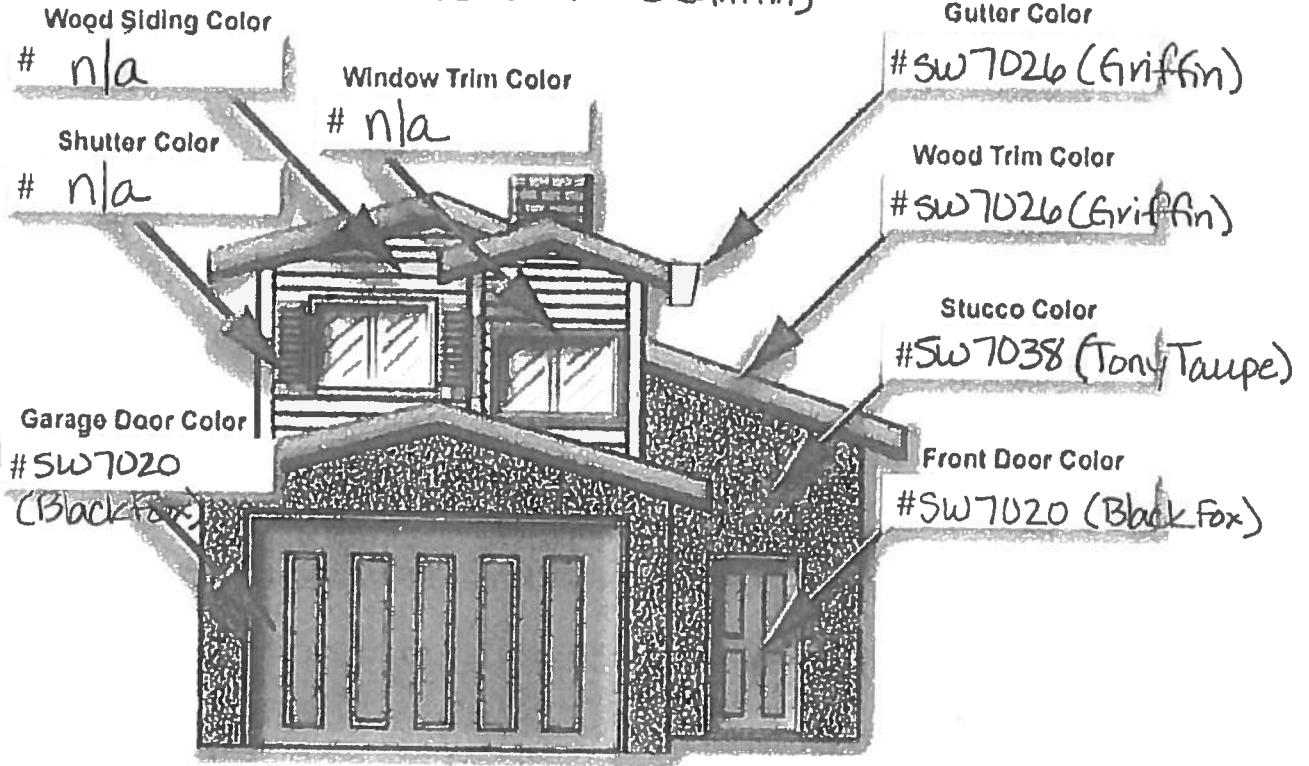
